# VESTRY MEETING MINUTES Monday, October 6, 2025, at 6:30 pm

The monthly vestry meeting was called to order by Rev. Katie and she opened with prayer. Rev. Katie welcomed Drew Robb to our meeting.

The minutes of the vestry meeting held on September 15, 2025, which were previously emailed to all members by Louise Barker, were addressed. Rev. Katie asked if there were changes that needed to be made. Hearing no changes, additions or corrections, Rev. Katie asked for motions to approve the minutes as written. #### Junior Warden's Report:

Rusty addressed the tree in the near corner of the new cemetery which is creating
damage to the wall surrounding the old cemetery. He has asked Al Burnett and Billy
Cate for their advice/opinion as to whether it should come down. All are in agreement
that it should. Rusty is going to look into taking it down with the help of others, but may
need to get a bid from a few professional services. If that is the case, he will ask for a
Robo call and vote.

### Senior Warden's Report:

- Jim reported that he is pleased with the attendance on Sunday at the Adult Formation forum. He is also pleased with the Sunday School program and the mural on the Sunday School wall that is in progress and will depict the "Creation Story."
- Jim and Mary Ann plan to attend the Small Parish and Missions Church Retreat at Gravatt this coming weekend. He was pleased with the retreat he attended last year as it was an opportunity to get to know leaders of other small churches in the surrounding areas.
- Rev. Katie tagged onto this information about the retreat. She is the commissioner of Small Church Ministries and their mission is to create and repair relationships of small churches and foster a sense of cooperation. She is excited about the retreat. Katie is setting up online giving this year whereby members can register online to pledge and give by setting up for withdrawal from their bank account. Anne Lott will be the administrator. Rev.
